EXISTING CONTROL MEASURES
1. Make sure all wires are tucked away. Make sure trip hazards are moved out of the way. Areas where children are present should be free of trip hazards.
2. Ask parents at the start of the performance whether there are any children who are allergic to eggs or chocolate. Take appropriate action if those children are identified.
3. Make sure there are paper towels available to mop up any spillages. Spillages should be cleared up immediately. Make individuals aware of the slip hazard.
4. Lighter should be locked when not in use and stored out of the way of children (or handed to a responsible adult). This experiment should be carried out in a tray filled with sand. A bottle of water should be available and added to the flask once the experiment is finished to extinguish any flame and reduce the amount of smoke. Children should be kept safe distance away for this part of the performance.
5. All electrical items used in the performance should be PAT tested.
6. First aider present in case of an accident.
7. First aid kit available if required
